| <p><b>PRESIDENT'S REPORT</b></p> <p>The President had been lobbying and promoting Canoe within the Olympic Family, particularly regarding the future in the Olympic Programme.</p> <p>Visits included Sport for All (PER), Sport Accord (RUS), IOC womens commission (SUI), World Games (COL), Athletics World Championships (RUS), IOC Session (ARG)</p> <p>The President announced his candidature for President of World Games. Election will be held April 2014.</p> <p>ICF welcomed the inclusion of Canoeing in the inaugural European Games in Baku, 2015.</p> <p>The issue of Stand Up Paddling and who owned the sport was discussed as Surfing Federation had asked the ICF to give all rights to them. It was noted that in Germany stand up paddling was under the canoeing federation. **SECRETARY GENERAL'S REPORT**

It had been a busy and long competition season. Staff had changed in the HQ. By mutual decision Paula had left due to long term illness and would officially finish December 2013.

Marine Pergaeux would replace Paula full-time as she had been working part time for Archery Federation and ICF.  
Richard Pettit had also joined the ICF as media and communication manager.

The ICF had been occupied with the Rio 2016 Canoe Slalom course with Jean Michel Prono, Tony Estanguet, Joao Tomasini and Ramon Ganyet.

In addition, the governance project had taken up a lot of time as well which had not been foreseen for the Headquarters.

The ICF had overspent for the World Games but the events had been well received and successful in Cali, Colombia.

A new finance table was introduced to the BoD members. The ICF accountants and HQ were working on an electronic system that would allow the accounts to be calculated monthly and automatically. This was to be ready for the next financial year.

ICF TV for 2013 had been successful especially the World Cup audience figures. Both Canoe Sprint and Slalom World Championships had good figures.

Expansion into non-European territories was required now to grow the audience further.

For the eight world cup events a total of 28 million viewers had watched which had been a significant increase on previous years. In total there were 39 hours of live TV for ICF World Cups and 50 hours for World Championships resulting in nearly 100 hours of live TV for canoeing in 2013.

A decrease in takers of the highlights programmes occurred but this was more likely due to the increase in live broadcasts.

There was a commitment based on feedback from various sources to improve the Canoe Sprint World Cup TV production and this had already started with ICF TV for 2014.

Once again it was highlighted that the timing system for Canoe Sprint was causing major problems in the TV production and final product.

He continued to work with ANOC on the African Games to ensure Canoe was on the programme.</p> <p><b>Joao Tomasini – Report</b></p> <p>It was highlighted that work was progressing daily on the 2016 canoe slalom course with the Brazil Canoe Federation working closely with Rio 2016 and ICF to find a good solution for the Games and the legacy of the venue.</p> |  |  |

| <p>NFs to discuss all technical issues. Future planning would be based on this meeting and has helped formulate ideas. NFs requested a reduced competition programme. Similar feedback had resulted from the Canoe Summit meeting held in Lausanne.</p> <p>For the next Congress it would be proposed to delete Relay events as they were not working and add team boats particularly canoe as proposed from the Canoe Summit.</p> <p>Potential Olympic events would have to meet performance targets to be eligible for inclusion for the Olympic Games and each event would be measured against each other. | <p><b>CANOE SLALOM – Jean Michel Prono</b></p> <p>Canoe Slalom events had been successful in terms of operation and TV audiences which was satisfactory for post Olympic year.</p> <p>Organisers had used the siwidata package and TVS had been standardised for all events. Progress had been made in accreditation systems and the next step was to standardise data processing in ISIS.</p> <p>Junior World championships in Liptovsky (SVK) was very successful, however it was a heavy programme. In the future, issues could arise affecting quality of the Junior event. Perhaps the ICF should revisit the programme in the next Congress.</p> <p>The World Championships was extremely well organised in Prague (CZE) they not only recovered from course flooding but also delivered a fantastic event which was a credit to the organisers.</p> <p>Progress to increase participation in the C1 women class had continued. Improvements in showcasing the C1 women required the ICF to look at the length of the runs and the time taken for athletes to complete the course. By changing the course we could hope to improve the athlete's time and the image of the competition.</p> <p>Canoe Slalom has been concerned with the Rio 2016 course preparation. selected for Rio 2016 was approved.

The base of the Qualification System reflected the London 2012 model.

The 1<sup>st</sup> qualification would be the 2015 World Championships Milan. The second qualification would be the continental qualification as separate events.

The major change was that athletes would not be able to compete in the second qualification event if they obtained a quota in the World Championships. The BoD approved this principle.

The ICF decided that at least four NFs in each race in 2<sup>nd</sup> qualifier to be a legitimate race. (Note: IOC replied post BoD meeting that this was not a good legal decision and recommended 3 in line with ICF competition rules).

It was proposed to reduce the K4 from 10 to 9 crews with 3 continents and add 4 new K2s in the second qualification. The BoD voted against the proposal and instead insisted on 10 K4 teams and 4 continents.

A discussion was held regarding quality of athletes and the balance of Universality. The BoD agreed it was difficult to separate the two and the proposed plan was acceptable for continental representation and high performance.

It was recommended that once Quotas had been attributed at the World Championships they would remain with the rankings of the World Championships and similar for Continental Qualification quotas. The BoD approved this principle.

The Qualification System would be adjusted accordingly and sent to the IOC for their input and approval.

### **Canoe Slalom**

A proposal by the Slalom Committee was that Qualification would be done through ICF Ranking using the 2014 and 2015 seasons.

A debate occurred regarding the positives and negatives of Ranking verse one off Qualification events.

The use of ICF Ranking selection proposal for Rio 2016 was not approved by the BoD. The BoD voted in favour to keep the Qualification System similar to London 2012.



| <p>event.</p> <p>The BoD accepted under exceptional circumstances that the Pan-American Games could be used for Qualification even though the event was before the World Championships.</p> <p>A C2 Men boat would be given a host nation place as agreed by the BoD for Rio 2016.</p> <p>For qualification if an NF did not have an athlete qualified in a specific event at Rio 2016 then they could enter in that event any athlete already qualified for the Games. This principle was approved by the BoD.</p> <p>The Qualification System would be redrafted by the Chair and Secretary General to meet the IOC pending deadline.</p>   |  |  |
| <p><b>CANOEING AND OLYMPIC GAMES 2020 AND BEYOND</b></p> <p>A discussion was held over the future of the Canoeing Olympic Programme Debate. For the Olympic Games in Rio 2016 it was reconfirmed that the Olympic Programme would remain the same as London 2012.</p> <p>For Canoe Slalom it was proposed to keep the K1 men, C1 men and K1 women. It was also proposed to remove C2 men and add C1 women from the Olympic Games starting in 2020. This was approved by the BoD.</p> <p>The BoD also discussed the possibility of a mixed C2 event. No clear decision was made.</p> <p>For Canoe Sprint a debate occurred on the timing of achieving Gender Equity in the Olympic Programme. Finally the BoD voted and agreed to have full Gender Equity achieved by the Olympic Games in 2024. For the Olympic Games in 2020 K2 200m men would be removed and C1 Women would be added.</p> <p>The use of performance indicators for deciding Olympic events was discussed and no clear decision was made on their use in the future.</p> |  |  |
| <p><b>GOVERNANCE REVIEW UPDATE AND DISCUSSION</b></p> <p>The project had started 2 years ago with a goal to propose a document to all NFs by the end of 2013. Unfortunately it could not be realised as consensus could not be found on the direction of the organisation.</p> <p>Documents would be sent to all NFs feedback and in January the document will be finalised to be presented in the congress.</p>  |  |  |

| <p>The draft document had only received one response from BoD members.</p> <p>During the meeting it had not been possible to discuss any issues relating to the document. It was decided to remove the 3 examples of Board structure and send to NFs with a broad range of possible ideas for structure changes. The paper would be distributed before the end of November 2013 to NFs for their feedback.</p> <p>It was decided to hold a final meeting in Lausanne in January 2014 to finalise the document including defining the Roles and Responsibilities, Board Structure, Executive Structure, Strategic Plan and ICF Working Policies.</p> <p>The President reminded the BoD that a commitment had been made to the Congress that the ICF would reform its Governance by 2014 and requested that a clear pathway should be drafted with the objective to achieve Governance change and suitable papers by November 2014.</p> <p>A questionnaire would be sent to the BoD members regarding their roles and responsibilities to help facilitate the work of the Working Group.</p> |  |  |

| <p><b>MISCELLANEOUS</b></p> <p>Botswana was provisionally added as an ICF member by the BoD. The ICF would now have 160 affiliated federations.</p> <p>The ICF BoD decided to award the following events: 2015 ICF Junior Wildwater Canoeing World Championships to Nantahala (USA) and the 2017 ICF Canoe Marathon World Championships to Pietermaritzburg (RSA).</p> <p>For the Beach Games the ICF supported NOC mandate and therefore the recognised body should be ICF and not IDBF.
